CALL FOR PAPERS

In the last years, on the ground of the economic and financial openness acceleration, the Eurozone has been confronted with different severe challenges. Within this framework, a specific attention can be devoted to the link between globalization and the future of the euro area (i.e. deeper European monetary and fiscal integration). This is particularly interesting to be analyzed within the context of the Globalization Paradox (Rodrick, 2011). The paradox suggests that it is difficult to pursue in the same time globalization, democracy and nation determination. If the Eurozone has been considered rather an exception to this paradox, the recent events underline that being an active participant in a globalized economy should go along in Europe with a stronger inter-country integration (e.g. at monetary, budgetary and trade level). And this could be seen also as a way to stimulate further growth at the European level. Researchers are invited to submit both theoretical and empirical papers dealing with these research topics.

All submitted papers will be peer reviewed according to a high-quality and fast referee process. Authors will be notified whether their paper is accepted for presentation at the special session not later than April 2, 2017.

Special session presenters are expected to discuss one other paper during the session. The discussant assignments will be made by the special session organizer(s) at a later date.
